Re: WARNING - Illegal use of Company Name and for selling/issuing fake tickets for Amarnath Yatra

We, Global Vectra Helicorp Limited (hereinafter referred as "GVHL") are a company registered under the Indian Companies Act, 1956 and are engaged in the business of providing helicopter services throughout India.

This notice is to bring to your attention that "Global Vectra" is a registered Trademark and the Company has the exclusive license to use, trade and deal with the name "Global Vectra" in India.

It has come to the knowledge of GVHL that Global Vectra Trips Private Limited is illegally using the Global Vectra name and is illegally misrepresenting themselves as having links to GVHL in selling/issuing fake/illegal tickets for Amarnath Yatra (including a helicopter service).

The misrepresented sale of tickets (including a helicopter service) and the use of the name "Global Vectra" by you is unauthorized and illegal and is a clear infringement of trademark rights for the "Global Vectra" mark. The infringement of a trademark attracts both civil and criminal penalties under the Trade Mark Act, 1999 and under other applicable laws and regulations.

We hereby advise you to discontinue, with immediate effect, using name of "Global Vectra" and to cease selling/issuing fake/illegal tickets for Amarnath Yatra and state categorically that any such tickets issued by you shall not be accepted for helicopter services provided by Global Vectra Helicorp Limited and a Public Notice to this effect shall be posted today, 8<sup>th</sup> March 2018.

Furthermore, providing you stop using the "Global Vectra" name and that you stop selling/issuing fake/illegal tickets for Amarnath Yatra (inclusive of a helicopter service) with immediate effect, we make a without prejudice offer not to take further action against you. However, should you ignore or otherwise fail take any action by Thursday 15<sup>th</sup> March 2018, we shall commence legal proceedings against you without further notice.

We require your positive response within 7 (seven) days of the date of this letter.
